**BONEO PARK / RED HILL A & H SOCIETY INC.****RISK MANAGEMENT CONDITIONS**

1. To ensure the quality of the surface, Boneo Park staff members will grade the arenas during all breaks.
2. Dogs are allowed at the venue providing they are on a lead at all times. No dogs are allowed in the Rider's Retreat, indoor arena, stable complex, practice or competition arenas. All droppings must be picked up.
3. Approved safety helmets must be worn at all times when riding.
4. Riding of horses bareback is prohibited.
5. Riding of rugged and/or unbridled horses is prohibited.
6. Stallions must at all times be in the control of a person aged seventeen years or more when led or ridden.
7. Horses are not permitted off the rubber areas within the stable precinct.
8. Bicycles are not permitted at the venue during the Red Hill event.
9. Speed limits must be adhered to at all times.
10. Power leads must not be lying on the ground. Holders will be provided.
11. Construction of portable tape yards is prohibited.
12. Alcohol must not be consumed by anyone riding later that day.
13. Smoking is only permitted in the designated areas (outside the Riders Retreat and the BBQ area.)
14. Children under 14 years must be under strict supervision at all times.
15. No infrastructure to be erected on Boneo Park without written approval by management prior to event, including stakes or pegs into the ground.
16. Signage must be obeyed at all times.
